## The Affordable Care Act and LA Actors: How to get health insurance

The Affordable Care Act may be up and running but it can be a bit confusing to actors trying to navigate the best options for themselves and their families. The good news is that there are quite a few new options for actors who didn't make the qualifying annual minimums, or have been out-priced of COBRA plans.

Here are three great resources available to

professional actors and performing artists to guide us through the best health insurance opportunities currently available.

# The Screen Actors Guild - Producers Pension and Health Plans

**SAG-PHP** just announced that actors will be able to combine their earnings under AFTRA PHP and SAG-PHP to meet the minimum eligibility requirement for the SAG-PHP Plan II, beginning July 1, 2014.

With the vote in March of 2012 to merge AFTRA and SAG, one of the major promises (and concerns) was regarding the combining of the two separate health plans. Last December, the SAG Producers Health Plan announced they were working on an option for actors who were not qualifying for coverage under either AFTRA HP or SAG-PHP, but earning under both. This latest announcement means that if one's combined earnings during the qualifying period (between April 1, 2013 through March 31, 2014) are at least \$15,100, you qualify for the SAG-PHP Plan II.

nation, which "identifies alternative routes to
coverage and local resources for care for small

businesses, performers, visual artists, stagehands, filmmakers, musicians, artisans, and other self-employed and episodic workers."

AHIRC offers health care reform workshops regularly, covering issues related to both private and government health insurance programs, as well as assistance via email and phone. Their workshop Finding Affordable Health Insurance with Covered California is offered regularly throughout 2014.

The Actors Fund also provides its own **Covered California Helpline** at 855.491.3357, specifically to answer questions about the Affordable Care Act as it pertains to actors.
